## PEAK AGGRESSIVE BEHAVIOR RATING SCALE QUESTIONS (2/8/02)

- 1) Have you ever been in a physical fight?
- 2) Thinking about your whole life, how many total fights have you been in?
- 3) During the period in your life when you were fighting most often, how often were you getting into fights?
- 4) How often did you cause injuries to the other person that would require medical attention (broken bones, stitches, etc.)?
  - *\*INQUIRE ABOUT INJURIES\** FOR ALL INJURIES ASK: 1) What was done to cause the injuries, 2) Description of the injuries, 3) What medical attention was required, 4) Where on the body the injuries occurred, 5) How many times the person was hit, shot, stabbed, etc., 6) If the person was hospitalized, if so for how long, 7) If the person was unconscious, if so for how long, 8) If they hit/kicked/etc. the person when they were down or unconscious, and 9) If there was permanent damage or impairment or death.
- 5) Did you ever use a weapon on somebody?
  - IF YES, List weapons used, situations in which the weapon was used, and how many times each weapon was used in each situation. For example, if a gun was used ask how many times it was used and how many times they shot the person. *\*INQUIRE ABOUT INJURIES FOR EACH SITUATION\**
  - IF A GUN WAS USED, ask if these were drive-by or face-to-face shootings, where on the body they shot the person (face, arm, etc.).  
*\*INQUIRE ABOUT INJURIES\**
  - IF A KNIFE WAS USED, ask if they sliced at the person or actually stabbed them, and where on the body the injuries occurred. *\*INQUIRE ABOUT INJURIES\**
  - IF STICKS, BOTTLES, BATS, CHAINS, ETC. WERE USED, ask where on the body the injuries occurred. *\*INQUIRE ABOUT INJURIES\**

- 6) Have you ever set fires?
  - IF YES, how many times, for each time what was burned (person or property), how much damage was done, and any injuries. \*INQUIRE ABOUT INJURIES\*
  
- 7) Have you ever done an armed robbery?
  - IF YES, how many times, for each time find out if they actually used the weapon. \*INQUIRE ABOUT INJURIES\*
  
- 8) Have you ever sexually assaulted anyone?
  - IF YES, how many times, what happened each time, if a weapon was used. \*INQUIRE ABOUT INJURIES\*
  
- 9) Have you ever tortured anyone?
  - IF YES, how many times, what happened each time. \*INQUIRE ABOUT INJURIES\*
  
- 10) Have you ever caused anyone to be hospitalized?
  - IF YES, what happened each time, how long was the person hospitalized. \*INQUIRE ABOUT INJURIES\*
  
- 11) Have you ever caused anyone to lose consciousness?
  - IF YES, what happened each time, how long was the person unconscious or hospitalized. \*INQUIRE ABOUT INJURIES\*
  
  - IF YES, did they hit/kick/etc. the person after they were unconscious? If so, how many times, where on the body, with what?
  
- 12) Have you ever killed someone or tried to kill someone?
  - IF YES, how many times, what happened each time. \*INQUIRE ABOUT INJURIES\*
  
- 13) What is the most aggressive or violent thing you have ever done?
  - WRITE DOWN A COMPLETE DESCRIPTION. \*INQUIRE ABOUT INJURIES\*
